

MORRISTOWN CITY COUNCIL MINUTES Regular Meeting January 3, 2005

A regular meeting of the Morristown City Council was called to order on Monday, January 3, 2005, at 7:00 p.m. in the Council Chambers at 402 Division Street South by Mayor Steve Felix. Councilmembers present were Verdis Flaten, Jeff Lang, Steve Nordmeier and Jared Taylor. Also present were Virginia Schmidtke, City Clerk/Treasurer; Randy Baumgard, Police Officer; John Schlie, Fire Chief; Linda Murphy, Community Center Manager; Jack Schwichtenberg, Barb Bruns, Loren Dahle, Larry Dahle and Dan Morris.

The Pledge of Allegiance was said.

Steve Felix administered the oath of office to Jeff Lang, Steve Nordmeier and Jared Taylor who were elected Councilmembers at the General Election held November 2, 2004 and Steve Nordmeier administered the oath of office to Steve Felix who was elected Mayor.

Motion by Nordmeier, seconded by Flaten and carried unanimously to approve the minutes of the regular meeting held December 6, 2004, the minutes of the Truth and Taxation meeting held December 7, 2004, the minutes a special meeting held December 9, 2004 and the minutes of the work session/special meeting held December 20, 2004 as printed.

A copy of the report is on file with the city. He also announced that an informal open house meeting to identify issues and potential improvements will be held Wednesday, January 5th from 6:00 p.m. – 8:00 p.m. at the Morristown Community Center. He encouraged everyone present to attend the meeting. Mayor Felix thanked Loren for the report.

Motion by Lang, seconded by Flaten and carried unanimously to give a three percent salary increase to Randy Baumgard, Wes Bell and Virginia Schmidtke effective January 1, 2005.

Discussion was held concerning setting goals for 2005. 

MORRISTOWN CITY COUNCIL MINUTES Work Session/Special Meeting January 18, 2005

A work session/special meeting of the Morristown City Council was called to order on Tuesday, January 18, 2005, at 7:00 p.m. in the Council Chambers at 402 Division Street South by Mayor Steve Felix. Councilmembers present were Verdis Flaten, Steve Nordmeier and Jared Taylor. Also present were Virginia Schmidtke, City Clerk/Treasurer and Randy Baumgard, Police Officer. Councilmember Jeff Lang was absent.

The Pledge of Allegiance was said.

Randy Baumgard presented the following bid from Ahlman's for a new gun: \$550 for trade in of the two guns the city currently owns, \$650 for a new gun and \$50 for two clips for a total of \$150. He also presented a bid of \$125.85 from Streicher's for a holster and mag holder. Jared Taylor stated that he talked to Mike Ahlman and Mike is willing to take another \$50 off the bid. The owner of any property so assessed, may at any time prior to certification of the assessment to the county auditor, pay the whole of the assessment on such property, with interest accrued to the date of payment, to the city treasurer, except that no interest shall be charged if the entire assessment is paid by November 15, 2005; and he may, at any time thereafter, pay to the city treasurer the entire amount of the assessment remaining unpaid, with interest accrued to December 31 of the year in which such payment is made. Such payment must be made before November 15 or interest will be charged through December 31 of the succeeding year.
